

**PRIX DU PUBLIC UBS
TERMS & CONDITIONS**

Voting periods : June 2nd – June 26th / July 1st – July 13th

1. Only one vote per day is allowed per person or electronic device.
2. You may cast your vote through the Prix du Public UBS website (<http://www.mjaf.ch/ubs>)
3. To help us run a fair vote in line with our terms & conditions, we store information from your computer or any other electronic device from which you cast your vote. The information includes your computer IP address, the type of browser and operating system you are using, and the time your vote was entered. Montreux Jazz Artists Foundation (MJAF) also stores a cookie on your computer or any other electronic device to uniquely identify your vote. By agreeing to the terms & conditions, you give MJAF and our partners your permission to collect this information from you.
4. UBS shall have the right to use the registration data in order to contact you with newsletters, marketing or promotional materials and other information but will not sell, rent or pass it or any other personal details to any other organisation.
5. MJAF, its sub-contractors and partners, cannot accept any responsibility whatsoever for any technical failure or malfunction or any other problem with any online system, server or provider or otherwise, which may result in any vote being lost or not properly registered or recorded.
6. Voting is available from June 2nd 2017 to June 26th 2017 (first voting period) and from July 1st to July 13th (final voting period) on this website: <http://www.mjaf.ch/ubs>. Votes can be cast from 2 p.m. (+1 GMT) on the start date until 12 a.m./midnight (+1 GMT) of the last day of the voting period. Votes received outside of the specified times will not be counted.
7. Votes are only accepted via the MJAF website. No voting is available by email, mail, telephone or any other method.
8. MJAF reserves the right to disqualify votes if it has reasonable grounds to suspect that fraudulent, excessive or suspicious patterns of voting have occurred, or if it considers there has been any attempt to unfairly influence the voting. This may include for example, votes from spambots, programmes designed to specifically vote continuously for one project, or from devices where it is evident that cookies have intentionally been disabled or other attempts have been made to try to vote in a way that is not in line with these terms & conditions.
9. If the person voting on www.mjaf.ch/ubs shall win a prize, this one cannot be exchanged for cash.
10. The results of the votes will be revealed by MJAF & UBS on social media (Facebook) and also on the website on July 1st (first voting period) and July 14th (final voting period). In the event of any fault, mistake, misunderstanding or dispute concerning the outcome of a vote or poll, or the operation of any part of the web based voting system, the decision of MJAF shall be final.
11. After the final voting period, 2 tickets per voting day will be randomly draw.
